In addition to forensic evaluations pertaining to sexual behaviors, I conduct evaluations for a variety of issues, including competency to stand trial, sentence mitigation, and military service related disability. I am currently practicing in North Carolina, Virginia, and within the District of Columbia.

February 2015 – March 2016. *Responsibilities:* At a Medium Security Facility on a Sensitive Needs Yard performed assessment of initial diagnosis and case conceptualization. Conducted ongoing diagnostic clarification, providing empirically supported treatment modalities to inmates in a Correctional Clinical Case Management System (CCCMS). Performed initial and annual psychological evaluations, individual psychotherapy and crisis management (assessment of potential for danger to self, danger to others and grave disability). Provided consultation and training to team members and support staff and was team lead for weekly interdisciplinary treatment teams.

I was part of the Quality Management Support Unit, which is responsible for implementing an effective performance management system to ensure consistency with the California Department of Corrections and Rehabilitation (CDCR) Health Care Services mission. I served as an advisor to institution executives within various disciplines and my responsibilities included applying quality concepts, principles, and theories to ensure appropriate systems, processes, and structures are in place within the institution to evaluate and improve the healthcare system. I co-led a team of Health Program Specialists from different healthcare disciplines to address low compliant areas within SVSP's annual performance improvement plan. This team established and implemented ongoing measurement and evaluation processes to assess the progress toward meeting the objectives set forth within the improvement plan, identified program areas that may need improvement and implemented a plan to facilitate that development, and take part in multidisciplinary committees.

Position: Contract Clinical Psychologist. **Naval Hospital Camp Lejeune (NHCL), Deployment Wellness Clinic**, NC. August 2011 - April 2014. Responsibilities: The Deployment Wellness Clinic specializes in the treatment of active duty Marines and Sailors who suffer from combat related trauma. My primary duties included but were not limited to, conducting initial psychological evaluations and providing individual and group mental health treatment to service members post-deployment. As part of my treatment approach in treating Marines and Sailors, I found it imperative to collaborate with Commanders and/or Medical Officers to discuss factors related to the service member's fit for duty status.

In conjunction with my primary duties, I was responsible for completion of mental health addendums as required for the initial medical board package with follow-up evaluations for Marines and Sailors who had been placed on the Temporary Disability Retired List (TDRL). Additionally, I performed competency to stand trial evaluations and forensic psychiatric evaluations and assessments in order to evaluate a service member's overall psychological health.

Position: Senior Psychologist Specialist. **California Department of State Hospitals -**

Coalinga State Hospital (CSH), Coalinga, CA. Nov. 2010 - July 2011. *Responsibilities:* As Senior Psychologist Specialist for the Positive Behavioral Support Team. This position entailed leading a team of behavioral consultants who interface with and train treatment teams throughout the hospital in the development of comprehensive behavioral plans targeting identified problematic behaviors. Clinically supervised one unlicensed psychologist, in addition to, the rotation of four pre-doctoral interns on the Mentally Disordered Offender units within the CSH Internship Program. I facilitated sex offender specific treatment groups, and took part as a committee member responsible for the development and training of sex offender specific treatment for clinicians working within the CA Department of Mental Health's Sex Offender Treatment Program (SOTP).

As a separate position within CSH, I conducted evaluations assessing individuals civilly committed under California PC 2972 (Mentally Disorder Offender). Evaluations are conducted annually to determine if the individual meets criteria for civil re-commitment. Evaluation assesses severity of mental illness, symptom management through psychotropic medication adherence, level of insight and judgment, treatment adherence, and potential risk for future violence if released into the community.

Position: Staff Psychologist, **Coalinga State Hospital (CSH)**, Coalinga, CA. Aug. 2009 - Nov. 2010. *Responsibilities:* Staff Psychologist in the opening of the hospital's first Mentally Disordered Offender (MDO) Intermediate Care Facility (ICF) Units. Continued to lead an interdisciplinary team serving a caseload of 25 males civilly committed as a result of their severe mental illness. Developed and implemented treatment groups, facilitated Anger Management group, and created behavioral modification guidelines and plans for individuals who exhibit various problematic behaviors. Developed and supervised a pre-doctoral internship rotation on the Mentally Disordered Offender units whereby four interns within the CSH Internship Program individually rotated through that specific rotation throughout the year. I continued to facilitate sex offender specific treatment groups whereby each intern co-facilitated within that group for a quarter in order to enhance group treatment skills and learn that specific phase of the sex offender treatment program.

Oct. 2008 - Aug. 2009. *Responsibilities:* Staff Psychologist on an (ICF) unit leading an interdisciplinary team in a Wellness and Recovery Model for a caseload of approximately 25-50 men who have either been civilly committed or detained under probable cause as a Sexually Violent Predator. Facilitated sex offender specific treatment groups.

Sept. 2007 - Sept. 2008. *Responsibilities:* Provided individual and group psychotherapy for men on probation/parole of whom were court mandated to attend a sex offender specific treatment program.
