Per the NCSCLE Evidence Submission Policy 3.11 Additional Evidence Submission Policies for Latent Evidence and Forensic- Effective Date 10/15/2018 and Update Vol 2 No 5- dated Oct 11, 2018:

Latent Evidence will accept up to ten latent lifts and/or photographs per submission. A latent lift is defined as one piece of tape on a backing card, piece of paper, or pre-made fingerprint lifter such as a hinge lifter or gel lift. The latent lift must be no larger than 8.5 in. x 11 in. (Ex: Three individual pieces of tape on one backing card are three lifts). Photographs may be submitted as hard copies or on a digital media storage device such as a DVD or flash drive. Any subject or victim elimination prints will not count toward the ten lift limit per submission.

· Any subsequent submission for the same case will also have the ten lift/photograph limit and will be worked in sequential order by date of submission.




