Root cause?

PCSO case 2018-07213 Item 4 was analyzed and found to contain no controlled substances. The report read "No controlled substances indicated" and no weight was reported. The current technical procedure for Drug Chemistry Analysis 5.5.3 requires results for non-controlled substances shall be reported as 'No controlled substances identified' and the net weight of the material with associated uncertainty shall be Reported if a net weight was recorded." There was a net weight recorded in the analysis notes.

Plan of Action:

-An amended report will be issued with corrected wording and reporting of the net weight. An additional correction in the "Disposition of Evidence" section will be made as well. "Illicit Drug" will read "Drug
